### Introducing the Greater Salt Lake Municipal Services District

The Greater Salt Lake Municipal Services District, also known as the MSD, is the service provider and contract administrator for White City Metro Township and several other MSD member communities (Town of Brighton, Metro Township, Emigration Canyon Metro Township, Kearns Metro Township, Magna Metro Copperton Township, Unincorporated Salt Lake County). The MSD works with each of its member communities to evaluate and address the needs of that community. The MSD Board of Trustees is composed of member community Mayors and a member of the Salt Lake County Council who represent the interest of their citizenry. The MSD receives its funding from the Metro Townships, the Town of Brighton and Unincorporated Salt Lake County communities through sales tax, Class B and C highway funds, fees, grants, and other revenues.

## Funding

The MSD receives its funding from the Metro Townships, the Town of Brighton and unincorporated communities through sales tax, Class B and C highway funds, fees, grants and other revenues. The MSD contracts with agencies to provide Public Works, Animal Services, Planning and Development, Engineering, Parks, Justice Courts, Municipal Prosecution and Indigent Legal Services.

The District's Board of Trustees contracts with Salt Lake County for most services. The Board sets service levels, allocates funding and establishes policies. The District's General Manager carries out the direction of the Board.

### Difference between the MSD and the Metro Townships:

The Metro Townships and the Town of Brighton are independent municipalities that are members of the MSD. Each MSD member has an elected Mayor and Council. These officials represent the interest of the citizens of the individual Township or Town.

The MSD Board of Trustees is made up of each of the Mayors of the Metro Townships, the Town of Brighton and a member of the Salt Lake County Council.

The MSD's role is to evaluate the needs of all the Metro Townships, the Town of Brighton, and Unincorporated Salt Lake County and to use the funding to accomplish those needs. The MSD is the service provider, and they oversee all contracts with agencies to provide the services. The MSD Board of Trustees also has sole property tax authority over the Greater Salt Lake Municipal Services District.

## Public Works Operations

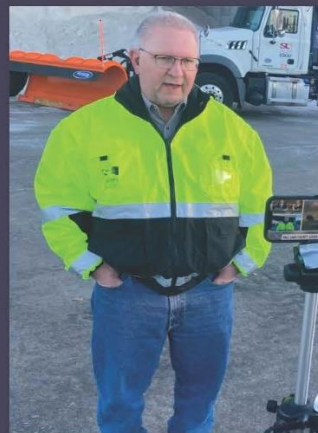
Public Works Operations provides full service street maintenance to White City as well as all of the Metro Townships and Unincorporated County through contract with the MSD. Public Works Operations also

## White City Seasonal Container Reservation Program (SCRP)

The Seasonal Container Reservation Program (SCRP), previously known as the Area Cleanup Program, is officially underway! Containers become available for reservation four weeks before the scheduled White City SCRPs dates. Residents will receive a postcard in the mail notifying them that reservations are now available. Once the postcards are delivered, you can reserve a container for the following dates:

**September 21 – 23**

Containers will be dropped off sometime between 7:00 a.m. and 5:00 p.m. on the scheduled day. WFWRD staff will try to ensure that residents have up to 24 hours with the container. Driveways must be cleared, accessible, and have enough room (approximately 10' x 20') for the container to be placed off the street and public sidewalk. If the driveway is inaccessible, the container will not be delivered, and you will lose your opportunity for the container at your residence. ### South Salt Lake Valley Mosquito Abatement District

Summer provides a great time to participate in a variety of outdoor activities. Unwelcome mosquitoes, however, can make many outdoor activities less enjoyable. Familiarity with basic mosquito biology and some simple precautions can help reduce the negative impacts of mosquitoes.

Mosquitoes complete the early stages of their life cycle in stagnant water in places ranging from ponds, marshy areas, and irrigated pasturelands to gutters, cavities in trees, and birdbaths. During the summer, nearly any water left standing for at least one week

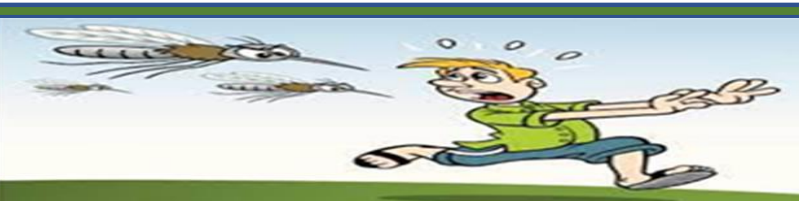
can provide suitable conditions for larval mosquitoes to develop into adults

Adult female mosquitoes take blood meals to obtain the protein required for egg production. In addition to causing an irritating allergic reaction, mosquito bites can facilitate disease transmission. West Nile virus is an example of a disease transmitted by mosquitoes in the Salt Lake Valley.

South Salt Lake Valley Mosquito Abatement District (SSLVMAD) seeks to promote public health and quality of life by reducing the number of larval mosquitoes that develop to the adult stage. District technicians regularly inspect known larval mosquito habitats in the Salt Lake Valley and apply mosquito control measures as needed. Treatments targeting adult mosquitoes are also used when appropriate. You can help control the population of mosquitoes by:

- Eliminating unnecessary standing water from your property.
- Emptying and refreshing desirable standing water at least weekly
- Treating livestock watering troughs and ornamental ponds with mosquito control products (this service is available free of charge from the SSLVMAD).
- Reporting other standing water to the SSLVMAD. Additionally, the following suggestions can help You avoid being bitten by mosquitoes:
- Use mosquito repellents approved by the Environmental Protection Agency according to instructions on the product label.
- Wear light-colored, loose-fitting clothing that covers as much skin as possible when outdoors.
- Avoid outdoor activities during times of peak Mosquito activity (between dusk and dawn for several species of mosquitoes, including disease vectors known to occur in Utah).

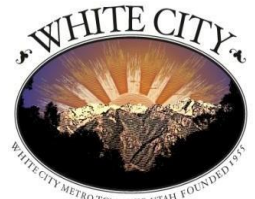

- New and/or renovated accessible restrooms at the following trailheads: New trailhead and parking lot, Dimple Dell Road, and Wrangler
- Renovated restrooms for year-round use at Dimple Dell Road and Wrangler

### Trailheads

- Accessible picnic area at Wrangler Trailhead
- ADA stalls and accessible route to restrooms at Dimple Dell Road trailhead
- Improved parking area at 300 e
- New trailhead kiosks, wayfinding signage, and interpretive areas New Trailhead near lone peak Park

### Fire Prevention/Suppression and Erosion Mitigation

- Removing invasive species from the pond and restoring water levels for fire response
- Adding two additional fire hydrants and repair of fire access gates

### Vegetation Management

- Three test plot areas that have been negatively impacted by invasive species will inform the process for re-establishing native plants throughout the park.
- Specialized equipment with rotary cutters will be used to safely mow grasses and invasive species—these machines do not till or dig
- Test plots will be roped or fenced off to control the test site and allow for uninterrupted reestablishment of native seed mixes  
Some areas (Larkspur and Flanders Point) within the test plots will have temporary irrigation installed

### Restoration

- Improvements to the Spencer House

### Completed

- Natural restoration and removal of the amphitheater near Dimple Dell Road
- Wood chip maintenance on soft-surface trails
- Parking lot resurfacing with gravel at Dimple Dell Road and Mount Jordan trailheads
- Year-Round restroom at Dimple Dell Road trailhead
- ADA stalls and accessible route to restrooms at Dimple Dell Road trailhead
- Fall fire prevention event near The Villages at Dimple Dell

- Establishing baseline plant data and seeding of all three test plot areas
- Water management infrastructure improvements including well and pump house repairs
- Poulson House site Master Plan

Funding for these projects is made possible by Salt Lake County voters and the [2016 ZAP 3 Parks & Recreation Bond](#).

Project Timeline: 2017-March 2020  
Planning Process: April 2020  
Implementation Begins: Fall 2022  
Anticipated completion

## Proposed Sego Lily Drive Improvements

Sego Lily Drive is the main thoroughfare into, out of, and through White City and as such is an important asset to the community as a whole as well as to those whose houses are along it. The road from 700 East to 1300 East was designed and developed with the same roadway and right-of-way width for the full length through White City. The right-of-way width (the area belonging to the general public), includes the road width, the curb and gutter area, and extends from the back of gutter an additional 10' towards the houses. This 10' space behind the gutter is where sidewalks and buffer/park strips are generally constructed.

As the community was being built out in the 1950's, the builders were allowed to defer construction of the sidewalk in the right-of-way space behind the gutter with the intention that as the need arose sidewalks would be constructed there later. This provided some cost savings to the home buyers. At some point in the early 1960's, in the stretch from Flint Drive to 1300 East, sidewalk and buffer/park strips were required and constructed within the dedicated right-of-way space as the properties were developed. This provides approximately half of the length of Sego Lily with a safe path for pedestrians, and leaves the west half without. There is now public demand for safe pedestrian space along the west half of Sego Lily Drive.

Without sidewalks to fill the public right-of-way space in the 10' behind the gutter from Flint Drive to 700 East, residents have over the years built and maintained their yard area out to the gutter, with some putting in trees, fences, and other landscaping within this public right-of-way area. Many don't even realize that this 10' space behind the existing gutter is not their property and is not included in the lot area that they pay taxes for. Many of them would be disappointed to lose the use of this space and the landscape improvements that they have been maintaining and using for decades.

In early 2020 we provided a survey to the residents along Sego Lily Drive regarding various options that could meet the needs of the community for safe pedestrian travel, bicycle use, parking, and vehicle

speeds. The survey results have not shown a strong consensus from the community as to a clear preference for a specific solution, but they have shown what elements the majority of the survey respondents would like to see added to Segó Lily Drive. A summary of the results of that survey is as follows:

- 58% of respondents had a preference for keeping parking available on the shoulder
- 59% of respondents had a preference for providing dedicated pedestrian paths
- 54% of respondents had a preference for providing a path for bicyclists
- 62% of respondents want to keep the speed limit at 25 MPH

The engineering department is proposing a roadway cross section that they believe best captures the desires of the majority, honors the request from the Regional Active Transportation Plan for bike lanes on Segó Lily, increases safety on Segó Lily, provides a consistent look and feel for road users from 700 East to 1300 East, and provides a compromise between best use of the public right-of-way and the expectation of the homeowners along the west half of Segó Lily who would like to continue to have some use of portions of their yards that are within the public right-of-way.

The roadway cross section from Flint Drive to 1300 East will remain the same, with no new construction proposed other than resurfacing the road and re-striping the lane widths to accommodate the bike lanes, updating pedestrian ramps to meet ADA requirements as needed, and providing streetlights.

The roadway cross section from 700 East to Flint Drive will keep the same overall road width and will include the same improvements that the east half will receive but will also have new curb and gutter in the location of the existing gutter and new 6' sidewalks on the yard side of the gutter (in the public right-of-way area). The

improvements is that the east side has a buffer/park strip, and the west side will have the sidewalk right up main difference between the existing east side improvements and the proposed west side

against the back of curb. This is to reduce the impact to the existing yard improvements that have been built up to the existing back of gutter. New 6" curb and gutter will be constructed on the west half to help keep separation between the parking shoulder and the sidewalk.

In this plan, all existing landscape improvements within the area affected by construction of the sidewalk would be removed. Existing yard sprinkler systems would be relocated to the new back of walk with sod replaced in any disturbed areas. Fences would be relocated if possible or replaced with 4' chain link fence at the new back of walk location. Trees, shrubs, bushes, rocks, or other landscaping in this space would be removed and not replaced.

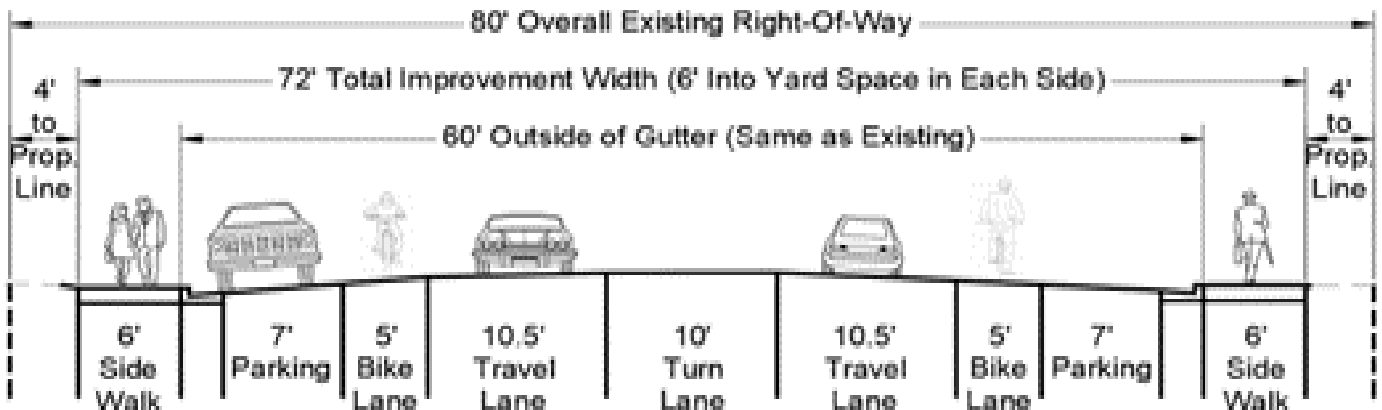
Some of the benefits of this proposed cross section are:

- It allows for use of the public right-of-way as it was intended to be used
- It provides bike lanes in each direction, creating a necessary link in the regional transportation plan
- It maintains parking along both sides of the road
- It provides a 6' sidewalk width on both sides of the road
- It reduces travel lane widths, which can reduce vehicle speeds
